## Presentation - Lockheed Martin: Kim Lowry and Tony Chowdry

- Lockheed Martin offers the Firehawk, a Blackhawk with fire capabilities. They have been gaining traction with LA County, CALFIRE, San Diego, Colorado, and other regions.
- They can operate around the clock and in harsh winds.
- Lockheed Martin also is working on a firefighting intelligence system for wildfire detection and response that will produce time-sensitive data to help minimize the threat of wildfires and enhance response efforts.
- Also working on a technology to auto-generate the perimeter of wildfires.

- CFSI is also supporting several standalone bills and hopes to see them pass this Congress.
- The Fire Caucus stands at 219 members, but used to be almost double that. Please join us in helping to grow the caucus.
